
- Meeting with with the Rectors/Vice-Rectors of the Ukrainian partner HEIs,


















News from KROK

Meanwhile, enrollment in the third group of the Master of Mediation and Conflict Resolution program continues. Classes start in November 2021.












Presentation of International MEDIATS Publication




Summer Mediation School

We see it as a very good impact of the MEDIATS project and do hope for more and more such cooperations!


News from ISU and BSU




News from ISU

- 2. Referral to mediation. Role of judges, social workers, and lawyers.








News from KKNU

News from CHNU

The main results of the impact of the implementation of the «MEDIATS» grant project at the individual level

- 1) 14 Masters of Law, along with the acquisition of the specialty of a lawyer, have already received the additional specialty of a professional mediator;
- 2) 15 Masters of Law, along with the acquisition of the specialty of a lawyer, continue to acquire additionally the specialty of a professional mediator;
- 3) Graduates of the University Bachelor's Degree in Law now have the opportunity to acquire, next to the profession of a lawyer, the specialty of a professional mediator;
- 4) The residents of the Chernivtsi city and the Chernivtsi region now have an alternative in resolving disputes, primarily through mediation;
- 5) 6 people of scientific and pedagogical staff of the Faculty of Law of the University completed an internship at the Netherlands Business Academy (Breda, the Netherlands), at the TURIBA University (Riga, Latvia), and at the Catholic University of San Antonio (Murcia, Spain) with a general volume of 9 ECTS credits each;





- 6) All members of the project team improved their knowledge of English, including one of them, passed the English exam at C1 level, three people made a similar exam at B2 level;
- 7) All scientific and pedagogical staff involved in the implementation of the EPP "Mediation" have been enriched with new European methods of organizing and implementing the educational process.



Synergistic effect of the implementation of the MEDIATS grant project at the level of the Faculty of Law

The project group "MEDIATS" of the University:

- 1) organized with the assistance of the EU grant program "Pravo-Justice", an international audit of the quality of educating of Bachelor of Law from Chernivtsi law school. The audit was carried out by the Vilnius University of Lithuania. The conclusions of the auditors were taken as a basis for a radical improvement of the Faculty's Bachelor's degree program in law;
- 2) developed "Principles and procedures for ensuring the quality of education, which is provided by the Faculty of Law of the Yuriy Fedkovych Chernivtsi National University";





- 3) initiated the appearance of two more project applications at the Department of Public Law, which became the winners:
- a) in the grant Subprojects "Legal clinics agents for the popularization of mediation as a way of resolving disputes" (the project was implemented with the organizational and financial support of the International Renaissance Foundation);
- b) in a grant project of the USAID «Financial Sector Transformation» Program, which was funded by the United States Agency for International Development;
- 4) initiated the emergence of educational and scientific laboratories at four of the six departments of the faculty;
- 5) has been created the competition for master's educational programs;
- 6) the recognition of the Faculty of law of the university among law schools of Ukraine has been significantly increased.
