Internship at UCAM Within Framework of Erasmus+ Project MEDIATS



On October 15-27, 2021, 7 students of Master Degree Program «Mediation and Conflict Management» of KROK Business School did internship at Catholic University of Saint Anthony, Spain, within the framework of Erasmus+ Project «Mediation: Training and Society Transformation / MEDIATS»

During the internship the students:


- listened to lectures of Spanish mediation specialists, learnt the justice system in Spain, practiced skills in simulations and solving educational mediation cases (in English).

- practised in Digital Mediation a real innovation, the possibilities of which makes it possible to acquire skills while overcoming borders.
- met with experienced Spanish mediators and visited the Palace of Justice.
- mastered the features of corporate diplomacy and the use of mediation technologies in commercial activities on the example of Spanish companies with a long history with Prof. Manuel Egea.
- learnt the peculiarities of commercial law and the use of alternative dispute resolution tools with Prof. Jose Ruiz and Prof. Alejandro Zornoza.

Erasmus Days Celebration 2021



On October 20, 2021, the events of the EU Erasmus+ project MEDIATS «Mediation: Training and Society Transformation» for students of «KROK» University took place as part of the World Erasmus Days Celebration.

Students of Psychology and Global Business Management programs took part in the selection of participants for a two-week internship in the Netherlands. Selection committee consisted of Andrii Lotariev, Head of International Office, Olha Karpova, Director of KROK Business School, Olena Naumova, Associate Professor of Marketing and Behavioral Economics Department, Faculty of Economics and Entrepreneurship, Halyna Bohachenko, Project and Program Manager. The selection committee chose 7 students to participate in the internship program. It is worth noting that 5 of the selected students are alumni of Mediation and Conflict Management Master's degree program of KROK Business School. Internship for the second group at Netherlands Business Academy

The second group of KROK University students completed a two-week internship in mediation in frameworks of **Erasmus+ project "Mediation: Training and Society Transformation / MEDIATS"** at Netherlands Business Academy, Dordrecht, the Netherlands.



The students of KROK University of Bachelor and Master degree programs "Psychology", Master programs of KROK Business School - BSK "Global Business Management" and "Mediation and Conflict Management" participated in the internships. It is worthy to mention, that the students of "Global Business Management" are graduates of the first group of "Mediation and Conflict Management", implemented at KROK Business School - BSK.

The internship included an intensive program of training and practice, including simulations of the mediation process. Our students were trained by the leading mediators of the Netherlands: Jan van Zwieten, Gea van Klompenburg, Marjon Kuipers, representatives of the Mediation Bureau and the Court of the Netherlands, as well as learned about the peculiarities of criminal cases on the example of mediator Dana Rone from Turiba University, Latvia.





Together with students from Ukraine, students from partner HEIs from Azerbaijan and Georgia also participated in the internship, which gave them the opportunity to share experience in implementing and conducting mediation in different countries.

During the internship, students underwent the assessment conducted by the International Master Mediation Federation. According to the results of the assessment, students received diplomas International certified mediator, International Counselor of Mediation.

Ukrainian Parliament approves Law on Mediation

On 16 November 2021 the Verkhovna Rada of Ukraine has passed the law on mediation (No.3504).

The approved document proposes defining the legal basis and procedure for mediation in Ukraine.

The law defines the legal basis and procedure for conducting mediation as an out-of-court procedure for resolving a conflict (dispute), the principles of mediation, the status of a mediator, the requirements for its preparations and other issues related to this procedure.

The document envisages that mediation may be used in any conflicts (disputes) that arise in civil, family, labor, economic, administrative legal relations, as well as in criminal proceedings during the conclusion of reconciliation agreements between a victim and a suspect (defendant), and other social spheres.

Also, individuals and legal entities will be able to apply for mediation at any stage of a dispute (before court, arbitration court or international commercial arbitration proceedings commence, as well as during ongoing proceedings and enforcement).

According to the document, mediation will be conducted upon parties' consent and in line with the principles of voluntariness, confidentiality, independence and neutrality, impartiality of the mediator, self-determination and equality of parties, etc.

THE LAW ON MEDIATION HAS BEEN ADOPTED! How does this bring Ukraine closer to Europe?

✓ Promotion of out-of-court resolution of disputes.

Resolving business, neighborhood, family, labor and other conflicts through mediation is a common thing in most European countries. That is not because citizens of European countries are more conscious or easier to communicate with their opponents in a conflict. Most European countries have programs to actively promote out-of-court dispute resolution through Mediation, such as:





- informing about Mediation,
- paying for mediation services for certain categories of cases (including all divorcing parents),
- refunding court fees in case of peaceful settlement of a dispute through mediation,
- and even obliging people to try mediation before going to court.

Without going into the analysis of the methods chosen by different European countries, Ukrainians should be congratulated on the fact that the adoption of the Law on Mediation will allow to return 60% of court fees in case of amicable resolution or withdrawal of a claim as the result of use of mediation.

✓ Promotion of development of small business.

Small business is one of the largest beneficiaries of mediation in Europe after divorcing families. Impossibility to retain staff of lawyers, extended and costly litigation force small businesses to abandon their interests, even in cases where a court decision would probably be in their favor. Distracting the owner's time and attention from the business to litigation does not allow small businesses to defend their rights in court on equal terms.

Large corporations successfully use that fact, making efforts to prolong consideration of court cases. Conflicts with large suppliers or buyers can be critical for financial security of small businesses. And the disclosure of a conflict or internal confidential information leads to reputational losses. The Law on Mediation is another step towards small businesses' access to justice in the broadest sense.

✓ Even before the adoption of the Law students of KROK Business School were brought closer to the European experience, as they had an opportunity to participate in internship programs in Spain and the Netherlands and see for themselves how it works there.

Mediation training in Ukraine has proved itself at the global level long ago. How do we know this? From the feedback of students undergoing internship in international groups. From the reviews of professional international mentors. From the International Mediator Certificates received by students of BSK program "Master of Mediation and Conflict Management" after passing the qualification exam. And from international simulations conducted by Ukrainian mediators with colleagues from the United States and Great Britain.

Two weeks passed like a flash. I am glad that our Ukrainian group #bsk represented Ukraine at a high level - all representatives of our group received diplomas of the highest level International Certified Mediator and International Counselor of Mediation.

Mediation is very common in the Netherlands. Ordinary citizens know about it and actively turn to mediators in various cases - from criminal, as well as to the settlement of disputes between neighbors, which impressed me personally, a kind of neighborhood mediation.

Among Ukrainian mediators there is a well-established stereotype that work in family cases should be done by a pair of co-mediators, a man and a woman, and it is best to combine mediators with different backgrounds - ideally a lawyer and psychologist. In Dutch colleagues, family cases are considered by a single mediator. It also does not matter the gender of the mediator, there is no concept of "ideal pair of co-mediators", no matter what educational or professional background the mediator has. That's what it means - a country free from prejudice, gender equality)) Only professionalism is important, not these conventions. Almost 40 students from Ukraine, Georgia and Azerbaijan practiced mediation daily for two weeks under the watchful eye of the best teachers from the Netherlands and Latvia. The language of communication is English. But as my colleagues and I joked, after two weeks of transcultural interventions - switched to Ukrainian-Azerbaijani-English surzhik with Dutch dialect))





During the training they had the opportunity to learn from the experience of conducting and implementing mediation from colleagues from other countries, and to understand the peculiarities of the implementation of mediation in Georgia, Azerbaijan, the Netherlands, Latvia.

During the internship we all sang a Dutch song to our birthday girls and witnessed the offer of a hand and heart, delighted colleagues by turning on every morning "Good morning, Ukraine!"

And beyond social networks and reports, there are incredible emotions, a sea of communication, dating, laughter, adventure, drive, jokes, terribly beautiful landscapes and buildings, a bunch of incredible people, each of which is the future of mediation!

Employees - mediators are competitive in the labor market

In January 2021, 14 lawyers who specialized in Master's degree in Mediation graduated from Yuriy Fedkovych Chernivtsi National University. This specialization immediately preceded the Educational-Professional program "Mediation".

One of the most important indicators for an objective and unbiased assessment of the quality of an educational program is known to be the demand of its graduates by the labor market for the acquired specialty and taking into account the period of time spent by the graduate for his first employment.

In the first six months after graduating from the University of 14 lawyers - mediators, who graduated from CHNU at the beginning of 2021, by the beginning of September of the same year 11 people (78.6%) found a job in the specialty and were employed: 1 person in the Ministry of Justice of Ukraine, 1 - in the regional state administration, 4 - in various law enforcement agencies bodies of Ukraine, 4 - in the centers for the provision of free secondary legal aid, 1 - continued his studies in graduate school with a break from work. 3 people are temporarily not working as a lawyer-mediator.



In September 2021, they presented a joint study "The role of free will in the right to live under the digital transformation of society" within the 5th Kharkiv International Legal Forum.

Following the Forum, the results of the study will be published in a collective monograph.



NEW JOINT INITIATIVE IN MEDIATION

Active international cooperation of the MEDIATS project team received a new spin-off: joint certification program "Mediation skills in the social sphere and health care", implemented under the GIZ Project "Strengthening resources for sustainable development of host communities in Eastern Ukraine" of the cluster "Prospects Development of the Eastern Regions of Ukraine", which act on behalf of the German government.

Project implementation period: 02.08.2021 - 31.05.2022

The main goal of the project is to develop a practical certification program "Mediation skills in the social sphere and health care" for employees of medical and social institutions and to improve the level of communication skills among medical and social workers. Introduction of innovative methods of dispute resolution (mediation skills) in the practice of medical and social protection institutions, training of medical staff and social workers in conflict-free communication skills in order to create a safe and favourable environment for health workers and patients, social workers and clients, reduce social tensions and improve quality of medical and social care. Our project will provide health and social care workers with an innovative tool to reduce conflicts, offer mutually beneficial solutions to existing disputes and prevent new ones.

The project team included the next representatives of Karazin University (Ukraine) Viktor Savchenko, Inna Neskorodieva, Olena Parkhomenko, Kateryna Andreieva, Alina Serhieieva, who were trained during the





MEDIATS project, and international expert Dana Rone, Turiba University (Latvia). Participants of the MEDIATS project continue international cooperation in the field of mediation.

TRAINING ON NON-VIOLENT COMMUNICATION

Karazin Business School with the participation of the representative of the MEDIATS project team Olena Parkhomenko hosted an author's training of Karl Plesner and Olena Hantsyak-Kaskiv "Nonviolent Communication: Empathic Communication and the Use of Force / Power".

Karl Plesner is an international specialist in restoring social ties after destructive events, a certified trainer in Nonviolent Communication (CNVC, USA), a mediator, a facilitator of dialogues, and a specialist in restorative justice. Elena and Karl founded and run the peacekeeping school for adults "Engineers of Understanding".

During the event, participants learned about the key principles of nonviolent communication, discussed the importance of peaceful conflict resolution and the use of alternative dispute resolution methods (including mediation).



PROMOTION OF THE VALUES OF MEDIATION

On September 26, 2021, during the All-Ukrainian Internet Conference "Critical and Creative Thinking: Developing and Improving", MEDIATS project participant Olena Parkhomenko (Karazin University, Ukraine) presented her report "Free time and critical thinking: how to properly adjust students' free time"



News from ISU

Lecture for the new cohort of students of the updated Master's program in private (business) law by the Chairman of the Georgian Mediators Association, Mediator, Irakli Kandashvili

On October 19 and 23, 2021 within the framework of the ERASMUS + Project "MEDIATS: Training and Society Transformation" a lecture was delivered to a new cohort of students of the updated Master's program in private (business) law by the Chairman of the Georgian Mediators Association, Mediator, Irakli Kandashvili on a new alternative dispute resolution mechanism, mediation.

The following topics were discussed during the lecture:

- Legal challenges and importance of Mediation in Private law/analysis of the principles and the advantages of this form of ADR.
- Communication with the party to use the court and private mediation/practical aspects associated with the mediation procedures and the legal consequences of the process.

Launch of Mediation Module

The mediation module developed by the team of Ilia State University School of Law was launched on September 28, 2020 and last year 14 students have expressed an interest to study the module, which represented approximate 30% of the students enrolled in the updated program. The following year additionally 8 students were registered on the Mediation Module.

National Dissemination Seminar


On October 13, 2021, within the framework of the ERASMUS + Project "MEDIATS: Training and Society Transformation a national dissemination seminar was held jointly by BSU and ISU. The event was dedicated to the Erasmus + Days.

Project managers from ISU and BSU, Salome Gagnidze and Keti Devadze introduced the results of the MEDIATS project and future plans to the audience. Konstantine Chokoraia, Head of Law School Quality Assurance department, was also participated in this meeting and he presented an updated master program in Private (Business) law (Mediation Module).

The Chairman of Georgian Mediators Association, Irakli Kandashvili, ISU law School students, BSU academic staff, and students were also attended this event.

At the end of the national dissemination seminar, a wish for success was made for the students participating in the internship planned in Murcia, Spain.





Internships for students

An internship with EU financial support was held on 18-29 October at UCAM Universidad Católica, San Antonio de Murcia, Spain. 10 students from ISU, registered on Mediation Module, took part in it.

During the internship, students improved their qualifications in the field of mediation as an alternative dispute resolution tool. The training was included theoretical and practical sessions.

Simulation games and a virtual reality mediation process were planned by the host university. After the role plays, the process was evaluated by the experienced mediators and feedback was given to the students, as well as a discussion on problematic issues was held.

During the internship, visits were made to the Murcia Court and the Ministry of Justice, where students were introduced to the specifics of the institutions' work, and also during this visit, meetings were held with acting mediators who shared their experiences in the field of mediation.





Additionally, the two-week internship program was included cultural visits to the cities of Murcia and Cartagena.

Upon completion of the internship, participants were awarded certificates.



An internship with EU financial support was held on 1-14 November at Netherland Business Academy in Dordrecht, the Kingdom of the Netherlands. 4 students from ISU, registered on Mediation Module, took part in it.

Within the internship program students were given an overview of each stage of the Mediation Pyramid, after which participants were introduced to each stage of mediation in detail. Also, lectures on mediation were held about the principles, acquaintance of the parties to the mediation agreement and the mediator key features in the mediation process.

On a daily basis, lectures were given to the students by the acting mediators: Jan van Zwieten, Gea van Klompenburg and Marjon Kuipers. Students were also trained by invited lecturers from Latvia and the Netherlands.





During the program, students had an intensive daily role-play based on the theoretical knowledge and they constantly received feedback from experienced mediators.

At the end of the internship, the participants were examed, after which all four students from ISU received an international certificate.







News from GSU

The newly established "Mediation Center" has been started to operate at Ganja State University.

In order to contribute to the implementation of the mediation process in Azerbaijan, the "Mediation Center" had been established at the Ganja State University, accordingly to the Ganja State University partnership at the European Commission's Erasmus + program, the MEDIATS: Training and Society Transformation project and with the support of the Law of the Republic of Azerbaijan on Mediation which had been approved by the President of the Republic of Azerbaijan Ilham Aliyev with order number № 1555-VQ and on March 29 dated state decree.

The opening ceremony, which took place on October 16, 2021, had been attended by the rector of the University prof. Yusif Yusibov and with relevant university staff members. A special room has been allocated for the center, which was established under the Department of Innovations in the main educational building of the university, and this room has been equipped with equipment purchased with the support of both the MEDIATS project and the university administration co-financing.

The Rector of the University prof. Yusif Yusibov wished success to the staff at the opening ceremony and expressed satisfaction with the introduction of the new field of mediation at the university, and wished to give a motivational speech to Ruslan Mammadov, who had been appointed to the center on a voluntary basis. Despite the intensive and difficult internship program, our students actively participated and coped with the tasks with dignity.

Starting the mediation course organized by GSU, students had been passed the final assessments at the end of the two-weeks international internship program. Netherlands Business Academy in Dordrecht, November 1-14, 2021.

Student story 1

Dear Jeyhun M.,

First of all thanks to Khazar University for a great opportunity. Definetely NLBA internship effected our mindset, vision and will make positive impact on our career.

In the beginning we had accommodation misunderstanding, instead of agreed accommodation we were sent to the Europarcs cotteges which are 13 km distance from campus. In a few days the issue has been solved and we could concentrate on our education.

Trainings provided by Jan van Zwieten, Gea van Klompenburg, Marjon Kuipers, Mayke Smit, Dana Rose and 2 local judges. We had a lot of mediation practice. I am lucky that my practice groupmates were Kiev group coordinator Oksana Oliinyk, Kharkiv group coordinator Alina Serhieiva and expert Kristina Babenko. They are all experienced mediators and trainers in Ukraine and all succeed in internship. Practical exercises were very useful and interesting for me. They are also learned some HR approaches to the mediation process from me, so we had effective collaboration with Ukranian mediators.

The Mediation Pyramid was one of the most important parts of the study. I had a challenge about Reframing tecniques, but it was very useful. Main focus of the training was on querying and summarizing parts which are very important. Identifying conflicting interests and aligned interests also taught by the trainers.

Jan Zwieten's training about IQ, EQ, PhQ and SQ impressed me very much, because at my work usually we used to talk about EQ and IQ differences. PhQ and SQ will be new items that I will add to my program. Training about the differences between Leader, Manager, Mentor and Coach also was very interesting for me and I was actively participated. DISC analyses another useful training that I will use in my job.

I was really very happy to get International Certified Mediator diploma and do it only for one attempt. I know from my experience that to develop soft skills in a short time is impossible, so decided to use my HR skills. The result really motivated me, because HR skills very close to Mediation skills and experienced HR experts can be very successful mediators. I want to develop my knowledge and skills in mediation and be part of this society.

The main part of the trainings was dedicated to intensive seminars and practical exercises. After a two-week workshop, participants will take an exam at the end of the internship program, and if successful, will be awarded an international diploma.

Workshops

We are planning to organize **mediation and conflict management workshops**. The workshops will focus on the benefits of alternative dispute resolution processes and will provide participants (MBA students also





from other majors such as Business Administration and Management, HR managers, Lawyers etc.) an introduction to the mediation process and how this process can help them in resolving disputes. The workshops will be customized to focus on workplace conflict management.

Moreover, we are planning to organize information session about personality type tests – MBTI and DISC – which could be beneficial during mediation process in order to understand main values of the parties. On the other hand, during this project we had brand new approach – psychological approach – to mediation process which should be applied in Azerbaijan as well. For instance, systematic approach to family members in order to understand the role of family members of parties is highly important to achieve consequences at the end of mediation process.

It needs to be considered that participants of the project- Malak Karimova and Nilufar Alizada - have successfully completed the foundation Mediation course program which held by the Ministry of Justice of Azerbaijan Republic. While practicing mediation, it will be great opportunity for them as well as others, to apply foreign experience which learned durin
