

Since Mayke Smit is a lecturer at the Netherlands Business Academy and will also provide the course Systemic Approach in the train-the-trainer program of Mediats, I suggest to already use her book in the curriculum of the Master Mediation program.

About the book:

In Unraveling Dynamics in Mediation, Mayke Smit reveals the undercurrent that affects the interaction between people in relationships and conflicts. She introduces the basic principles of Systemic work, indicates how systemic patterns operate and invites you to see things from a systemic perspective in order to achieve sustainable solutions.

Smit distinguishes three levels of dynamics that are of significance in mediation:

- The family dynamics on an individual level
- The dynamics between clients
- The dynamics between clients and Mediator

Issues such as dealing with emotions, loss and communication patterns are covered as well. Smit describes various existing theories in a practical way for mediation in cases between two clients: divorces, labor disputes and neighbor conflicts. By providing various examples she illustrates how the theories and models can be applied with and without the use of table constellations.

This book is mainly aimed at Mediators and other professionals involved in mediation or conflict resolution. It is, however, equally useful to anyone interested in relationships and conflict. Throughout the book Smit also offers suggestions for examining and reflecting on yourself.

"The systemic Mediator guides parties beyond the conflict through an apparent systemic detour, which in fact leads to faster and more precise recognition and resolution. And that takes courage from the Mediator. The courage to ask "crazy" questions, and the courage to process your own patterns and background.







About Mayke Smit

Originally trained and working as a legal expert, Mayke Smit (1968) has been an independent trainer and Coach for many years, operating from the philosophy of Systemic work, in which she was thoroughly trained. She guides professionals in their personal growth and groups in transformation processes.

While writing her debut Los (2014) - a book about coping with divorce - Mayke developed a program for rebuilding one's life after divorce. She is a licensed intervision supervisor for lawyers and mediators and provides training in Systemic work for Mediators. The knowledge and experience she gained in her professional career is shared in Unraveling Dynamics in mediation, which is used in the (International) Master Mediation and is published in Dutch and English.

News from KKNU

New successes of Karazin Business School under the Erasmus + MEDIATS project.







This year, Karazin Business School opened its doors to a new group of Masters under the program "Management: Mediation". The curriculum is based on the Netherlands Business Academy Master's program in Mediation. Tutors within the program finished education with the support of professional mediators from the Netherlands, Spain and Latvia. It is modern European program with practical orientation.

All students will have possibility to participate in mobility to Netherlands or Spain in order to receive practical skills in Mediation from our partners.

Our future mediators have already started training in October 2020. However, admission for the Mediation Master program is still ongoing - do not miss the last chance!

News from ISU

The mediation module developed by the team of Ilia State University School of Law was launched on September 28, 2020, within the framework of the European Commission-funded "MEDIATS: Training and Society Transformation" project. The mediation module is integrated into the Master of Private (Business) Law Program. It is noteworthy, that a working group consisting of academic and administrative staff was set up specifically to work on the module, and even under pandemic conditions worked actively to develop the concept and structure of the module so that students could be admitted to the module by the fall of 2020.







The updated Master's Program gives students an opportunity to complete a 60-credit mediation module over a period of 2 years and to acquire the theoretical knowledge and skills necessary for a mediator. For this purpose, along with a master's degree, they will be awarded a special certificate confirming that they have completed the module.

Despite the fact, that the mediation represents an innovation for the Georgian law and the society, students' interest in the mediation module was high this semester. To date, 15 students have expressed an interest to study the module, which represent 30% of the students enrolled in the updated program.

The mediation module includes both theoretical and practical compulsory / elective courses. From the variety of courses offered by the module, students will study the following three lecture courses in the current semester:

- Legal regulation of mediation;
- Mediation practicum;
- Commercial Arbitration.

Due to the COVID-19 pandemic, studies at Ilia State University in the fall semester of 2020-2021 have been fully resumed in the online format.

Business School of KROK University established International Mediation Center



On 15 October 2020, by the Decree of Rector of KROK University, the International Mediation Center of KROK University (hereinafter - ICM) was established as a structural unit of KROK Business School.

The aim of International Mediation Center is to develop mediation, promote alternative dispute resolution through mediation, promote skills to lead the dialogue and solve problems in various areas through nonviolent communication, exchange of experience with international partners, mediation research, training and certification services to train professional mediators of different specializations.

The main objectives of the ICM are:

- Development of Master Degree Program "Mediation and Conflict Management" for the training of qualified mediators and short-term programs for advanced training of mediators;
- Development of international partnership, establishing partnerships in the areas of mediation research, exchange of experience, creation of training programs and other products, certification;
- Carrying out of scientific researches, processing and presentation of their results, their introduction in educational and practical activity;
- Establishment of a Mediation Laboratory for the provision of advisory and other services in the field of conflict resolution through mediation, dialogue and the use of other methods of alternative conflict and dispute resolution;
- Popularization of mediation in Ukraine, formation of culture of mediation application in society.

It is noteworthy to mention, that the **Mediation Federation of Ukraine** is on the final stage of registration. Soon the news on its creation will be published.







Events of CHNU Project Team of MEDIATS Project (June-September, 2020)

1. June 22, 2020. - Working group of the Project "Mediation: Training and Society Transformation/MEDIATS" of the EU Program ERASMUS + KA2: CBHE from the Yuriy Fedkovych Chernivtsi National University in according to the implementation Work plan, participated in a conference of the International Association for Humanistic Mediation. The conference was conducted by Mrs. Jacqueline Morineau, French mediator, author of books in mediation. This meeting was devoted to humanistic mediation and the development of mediation in different countries. At this meeting were more than 90 participants from seven countries: Ukraine, France, Belgium, Australia, Italy, Brazil, Mexico. At this conference was presented information about NGOs in mediation in Ukraine, especially Bukovinian Center of Mediation (BCM). Also working group give some information about MEDIATS Project and Master Degree Program in Mediation at the Faculty of Law of the Yuriy Fedkovych Chernivtsi National University.

2. June 27, 2020. – Pavlo Bartusiak, member of the Project team "Mediation: Training and Society Transformation/MEDIATS" from CHNU prepared blog post on the topic "Court-annexed mediation: the experience of the Netherlands". The Dutch model of court-annexed mediation is particularly interesting for Ukraine. This interest is caused by the fact, that the Ukrainian legislator is still looking for the optimal configuration for the legislative regulation of mediation, so that the latter meets the needs of society and, in particular, the professional community of practicing mediators. That is why any time-tested mediation practices of foreign countries are a valuable contribution to the development of the Ukrainian model of mediation.

Nowadays, Ukrainian society remains quite conservative in the use of means for alternative dispute resolution and traditionally prefers to resolve the vast majority of conflicts through the application to the courts. Instead, Ukrainian example of court-annexed mediation will help participants in litigation to become better acquainted with the very idea of mediation and its competitive advantages, and will allow them to consciously choose between "win-lose" (judicial procedure) and "win-win" (mediation) strategies. Finally, the practical results of implementation of the court-annexed mediation should change the negative attitude of most Ukrainian judges, lawyers and other legal practitioners to the concept of mediation, as it once happened in the Netherlands.

Blog post disclose such questions: What is court-annexed mediation? What are the activities of the mediation officers in courts? What are the activities of the mediation coordinators in courts? How do cases end up in court-annexed mediation? What happens with the court proceedings after the referral of the case







to court-annexed mediation? What are the stages of preparation, conducting and completion of court-annexed mediation?

3. **July, 2020.** - The MEDIATS project has significantly added to the positive image of the university, especially the Faculty of law. In the structure of the Department of Public Law, an educational and scientific laboratory for mediation, negotiation and arbitration has been formed and is dynamically developing. By the joint efforts of the university, the Faculty of law and the department, this laboratory was transformed into one of the best institutes of this type.

Evidence of the latter is at least that, with the active assistance of this laboratory, two more international grant projects were won at the faculty: "Legal clinics – agents for popularizing mediation as a way to resolve a dispute", which was carried out in 2019 under the project "Development of regional leadership and strengthening the model Coordination of the Association of Legal Clinics of Ukraine" and was funded by the International Renaissance Foundation and "Legal Clinics – Providers of Free Legal Aid to Consumers of Financial Services" (2020-2021), implemented as part of the USAID grant project "Transformation of the financial sector" and provides the involvement of mediators in resolving of real financial cases.

And now the next harvest, the real honey collection of the MEDIATS project team of the University: through the grant project "Mediation: Training and Society Transformation", for the quality implementation of the same project for the educational laboratory of mediation, negotiation and arbitration, it was acquired as international technical assistance of the EU Program ERASMUS + KA2: CBHE:

4. **July, 2020.** –The Certification Program "Professional Mediator" was finished. It was implemented within the framework of the task package №6 of the Erasmus + KA2 project No. 599010-EPP-1-2018-1-NL-EPPKA2-CBHE-JP "Mediation: training and society transformation/MEDIATS". This program was a joint project of the Mediation, Negotiation and Arbitration Laboratory of the Department of Public Law and the Faculty of Law. Graduates of the Certificate Program received certificates. In connection with the pandemic, the Certificate Program was issued online, and certificates were sent by post.

5. Ruslana Havrylyuk, manager of the grant Project "Mediation: Training and Society Transformation/MEDIATS" from CHNU and Petro Patsurkivskyy, professor, Dean of the Faculty of Law of CHNU, member of the Project team from CHNU published an article in the legal journal "Law of Ukraine". The aim of the article is to substantiate mediation as a value as one of the innate inalienable human rights. The subject, purpose, and objectives of the study identified the basic methodological tools of the article: practical philosophy and material phenomenology, which are effective tools for the cognition of such "invisible", according to M. Henri, "as a sphere of intersubjectivity", and the necessary approach that allowed analysis existential sources of mediation through the transcendental needs of individuals in goods. With their help: the quintessence of the positivist conception of the legal nature of mediation as an institution of judicial mediation is revealed; the basics of the human-centric concept of the legal nature of mediation are studied; the key provisions of the evaluation and the conclusions of the research are substantiated.

Mediation in accordance with the anthroposociocultural approach to legal knowledge has a dual legal nature. It is conditioned by man's attributive existential properties and the existential structure of the human world. This a priori attributes mediation as a value to innate and inalienable human rights. As a product of the fundamental (necessary) way of coexistence of individuals in society and at the same time a system of their interrelated legal obligations, through which a reconciled social environment is formed, mediation is also a public good, so it should be guaranteed by every state. Thus, mediation is the mutual legal self-protection of individuals. The most effective legal model of cooperation between the state and civil society in the implementation of mediation in everyday practice in the member states of the European Union has proven to be a public-private partnership of institutional type. In the positivist tradition of jurisprudence, mediation is seen as one of the aids in improving public justice.

6. *Petro Patsurkivskyy,* professor, Dean of the Faculty of Law of CHNU, member of the Project team from CHNU prepared post on the topic "Master's (Educational and Professional) Program "Mediation" at CHNU as a flexible innovative adaptive system".

Among the master's educational programs of the university there are many, the development of which was not stopped by the challenges of 2020. One of the brightest among them is the university's master's educational program in mediation. It is implemented by the university within the framework of the **Grant Agreement "Mediation: Training and Society Transformation (MEDIATS)" of the EU ERASMUS +: KA2: CBHE Program**, and the direct executor of this program is the project group of the Department of Public Law of the Faculty of Law, leaded by its head, Doctor of Law, Assoc. Prof. Ruslana Havrylyuk.

So, the recruitment for the master's program on the EPP "Mediation" in 2020, both quantitatively and qualitatively, surpassed the successful recruitment of 2019, as well as cautious expectations given the red-colored Chernivtsi region of the creators of this program through COVID-19. It should be noted the fact that this recruitment at the same time disappointingly frustrated all opponents and ill-wishers of the EPP "Mediation" both within the walls of the university and outside it. If we add to this the still predominantly







negative attitude in Ukraine towards mediation as a method of innovative conflict resolution in the interests of both (or more) conflicting parties, then this is an undoubted success.

What did make this success possible?

Its components are many, ranging from the high academic reputation of the CHNU.

However, I reasonably consider it necessary to highlight the main reason for this success. It lies in the fact that the *master's EPP "Mediation" at CHNU is a flexible innovative adaptive system*. In other words, it includes a systematic analysis of the conditions for its successful implementation and constant monitoring and urgent solution of problems of its development.

For example, the "bottleneck" of this educational program in 2019 was the small number of budget places — only 4 for those studying for it. This violated the legal requirements of the Grant Agreement "Mediation: Training and Society Transformation (MEDIATS)". Having thoroughly studied the reasons for this, the project group of the EPP "Mediation" found, within the legal framework of Ukraine, a way to solve the above problem. As a result, 14 budget-funded places were allocated for education at the EPP "Mediation" in 2020.

For applicants in 2019, the master's degree in mediation included 43 ECTS credits. This did not fully comply with European standards. Due to the deep analytical and large organizational work of the university's project group on mediation, the master's sectoral standard was improved, thanks to which the amount of special training in mediation increased to 65 ECTS credits, and the amount of practical training of master mediators – to 30 ECTS credits. In general, the master's program in mediation has been updated in 2020, compared to 2019, by more than half. The worldview component of the training of master mediators was significantly strengthened. As a result of the measures taken, the EPP "Mediation" began to fully comply with high European standards, and soon the applicants of the Yuriy Fedkovych Chernivtsi National University were also appreciated, choosing this program to obtain a master's degree.

7. Ruslana Havrylyuk, manager of the grant Project "Mediation: Training and Society Transformation/MEDIATS" from CHNU prepared post on the topic "Implementation of the master's standard for specialty **081** Law".

From September 1, 2020, the master's standard of higher education of Ukraine, specialty 081 Law, came into force. Its special competence Nº8 provides for the acquisition of the ability to use mediation and other legal instruments of alternative out-of-court consideration and resolution of legal disputes by persons studying in the master's educational program in the specialty of Law.

Somewhat earlier, I already noted that the need to include such special competence of students in master's educational programs was justified and lobbied by the project group of the Yuriy Fedkovych







Chernivtsi National University, participating from the university in the implementation of the Grant Project "Mediation: Training and Society Transformation" of the EU ERASMUS + Program: KA 2: CBHE.

After the official entry into force of the master's sectoral standard in the specialty 081 Law, it became necessary to ensure the acquisition of the above competence not only by persons studying in the educational program "Mediation" within the specialty of Law, but also by all other persons studying in the magistracy in the specialty Law.

In this regard, for the first time in Ukraine, the Department of Public Law of the Faculty of Law of the CHNU has developed a working program for the normative academic discipline "Alternative Dispute Resolution Tools". This discipline is taught in both educational master's programs of specialty 081 Law (EP "Law" and EP "Mediation"), as well as at the master's program EP "International Law", specialty 293 "International Law".

The amount of the entire curriculum is 5 credits, of which 45 hours are classroom lessons (15 hours of lectures and 30 hours of practical training) and 105 hours of students' independent work.

The curriculum provides for the mastering by students of two semantic modules. The first module "Genesis and basic properties of tools for alternative dispute resolution" includes the following content of the block: 1) ADR tools in the system of protection of human rights, freedoms and interests; 2) the emergence and development of ADR tools; 3) types and features of ADR tools; 4) legal regulation of ADR instruments; 5) the legal nature of the conflict

The second module "Basic tools for alternative dispute resolution" includes the following content of the block: 1) mediation in the ADR system; 2) restorative justice in the ADR system; 3) negotiations as a tool for ADR; 4) arbitration as an institution of ADR; 5) international commercial arbitration as an ADR instrument; 6) combined ADR tools.

Now the initial piloting for the masters of the Chernivtsi Law School has begun on the discipline "Alternative Dispute Resolution Tools".

September 14, 2020.** Students began their studies at the Master's Program "Mediation" within the Grant Project "Mediation: Training and Society Transformation" of the EU ERASMUS + Program: KA 2: CBHE. Due to the coronavirus pandemic "COVID-19", the first two weeks of studying took place online. However, starting on September 28, students continued their studies in a mixed form: lectures are held online, and practical classes are held in the classrooms of the university. This semester, students study the following disciplines during the training cycle: "Legal nature of mediation", "Restorative justice", "Psychological and ethical principles of mediation", "Mediation in family disputes".


profession in the Netherlands". The post describes access to the profession of mediator in the Netherlands. In the absence of a single regulation in the Netherlands, access to the mediation profession is regulated decentral through the relevant organizations. Currently, the main such organization is the Mediation Federation of the Netherlands, which maintains a register of certified mediators.

The quality standards of mediation services set by the Netherlands Mediation Federation and the principles of control over the provision of these services are the reason that registered mediators are in high demand in the market for alternative dispute resolution.

The Register of Mediators of the Netherlands Mediation Federation is recognized and used by the Dutch Judicial Council and the Netherlands Legal Aid Commission. In addition, only mediators registered with the Mediation Federation of the Netherlands can work in the court referral system.

The following steps for accessing the mediation profession are described: studying a basic course in mediation at an educational institution recognized by the Dutch Mediation Federation, an examination in mediation theory assessing mediator skills at the independent Examen bureau Intop, and obtaining a Certificate of Appropriate Behavior.
